

For the year ended April 30, 2017 (Unaudited - see Notice to Reader)

1. Purpose of the organization

Hythe & District Pioneer Homes Foundation is a local organization which assists in providing funding for transportation and recreational programs in the Hythe area. Hythe & District Pioneer Homes Foundation is incorporated under the Society Act of Alberta as a not-for-profit organization and is a registered charity under the Income Tax Act.

2. Significant accounting policies

Revenue recognition

The Hythe & District Pioneer Homes Foundation follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

3. Capital assets

Capital assets are initially recorded at cost. Amortization is provided using the straight-line method at rates intended to amortize the cost of assets over their estimated useful lives. In the year of acquisition, amortization is taken at one-half the applicable rate.

7. Income taxes

The organization is registered as a charitable organization under the Income Tax Act (the "Act") and as such is exempt from income taxes and is able to issue donation receipts for income tax purposes. In order to maintain its status as a registered charity under the Act, the organization must meet certain requirements within the Act. In the opinion of management, these requirements have been met.

8. Contributed services

Volunteers contribute many hours during the year to assist the Foundation in carrying out its service delivery activities. Because of the difficulty in determining their fair value, contributed services are not recognized in the financial statements.
